MEETINGS</p> <p>Section 1. <u>Parliamentary Authority</u></p> <p>All Joint Operating Committee meetings will be conducted in an orderly and business-like manner. Robert’s Rules of Order, Newly Revised, including group rules, shall govern the Joint Operating Committee in its deliberations in all cases in which it is not inconsistent with statute, regulations of the State Board, or Joint Operating Committee procedures.</p> <p>Section 2. <u>Quorum</u></p> <p>A quorum shall consist of a majority of the members of the Joint Operating Committee. No business shall be transacted at a meeting without a quorum, but the members present at such a meeting may adjourn to another time.</p> <p>Section 3. <u>Presiding Officer</u></p> <p>The Chairperson shall preside at all meetings of the Joint Operating Committee. In the absence, disability or disqualification of the Chairperson, the Vice Chairperson shall act instead. If neither person is present, a Joint Operating Committee member shall be elected Chairperson pro tempore by a plurality of those present to preside at that meeting only. The act of any person so designated shall be legal and binding.</p> <p>Section 4. <u>Notice</u></p> <p>Notice of all open public meetings of the Joint Operating Committee, including committee meetings and discussion sessions, shall be given by publication of the date, place, and time of such meetings in the newspaper(s) of general circulation designated by the Joint Operating Committee and the posting of such notice at the administrative offices of the Joint Operating Committee.</p> <p>a. Notice of stated meetings shall be given by publication and posting of a schedule showing the date, place and time of all stated meetings for the calendar year at least three (3) days prior to the time of the first stated meeting.</p>

Notice of all special meetings shall be given by publication and posting of notice at least twenty-four (24) hours prior to the time of the meeting, except that such notice shall be waived when a special meeting is called to deal with an actual emergency involving a clear and present danger to life or property.</p>
<p>65 Pa. C.S.A. Sec. 703, 709</p>	<p>c. Notice of all rescheduled meetings shall be given by publication and posting of notice at least twenty-four (24) hours prior to the time of the meeting.</p>
<p>65 Pa. C.S.A. Sec. 703</p>	<p>d. Notice of all recessed or reconvened meetings shall be given by posting a notice of the place, date and time of meeting and sending copies of such notice to interested parties.</p>
<p>65 Pa. C.S.A. Sec. 709</p>	<p>e. Notice of all public meetings shall be given to any newspaper(s) circulating in Cambria County and a radio or television station which so requests.</p> <p>f. Notice of all public meetings shall be given to any individual who so requests and provides a stamped, addressed envelope for such notification.</p>
<p>SC 423</p>	<p>Notice of all stated and special meetings of the Joint Operating Committee shall be given to Joint Operating Committee members prior to the time of the meeting.</p>

Sec. 701 et seq</p>	<p>Section 5. <u>Stated Meetings</u></p> <p>Stated meetings of the Joint Operating Committee shall be public and shall be held monthly in the Board Room, except when otherwise determined.</p> <p>a. Agenda</p> <p>Committee members shall refer all matters for consideration through the Administrative Director or the Joint Operating Committee Chairperson at least ten (10) days prior to the committee meeting. These items will be included in the agenda.</p> <p>Citizens desiring the reaction of the Joint Operating Committee on certain problems shall call these matters to the attention of the Administrative Director or Chairperson at least ten (10) days prior to the meeting of the committee. These items shall, or shall not, be placed on the agenda.</p>

Order Of Business</p> <p>The order of business for stated meetings shall be as follows, unless altered by the Chairperson or a majority of those present and voting:</p> <p>Call To Order Roll Call Of Members Invocation And Pledge Of Allegiance Comments, Visitor Introductions Approval Of Minutes Treasurer's Report And Payment Of Bills Correspondence Items For Information Only Executive Session For Personnel/Legal Matters Items Relating To Education And Personnel Items Relating To Budget And Finance Items Relating To Building And Grounds Items Relating To Student Activities Report Of The Administrative Director Report Of The Chief School Administrator Report Of The Solicitor Report Of The Joint Operating Committee Chairperson Future Meetings And Subcommittee Meeting Dates Other Business Adjournment</p> <p>Section 6. <u>Special Meetings</u></p> <p>Special meetings shall be public and may be called for special or general purposes.</p> <p>The Chairperson may call a special meeting at any time and shall call a special meeting upon presentation of the written requests of three (3) Joint Operating Committee members. Upon the Chairperson's failure or refusal to call a special meeting, such meeting may be called at any time by a majority of the Joint Operating Committee members.</p> <p>Section 7. <u>Hearing Of The Public</u></p> <p>A member of the public present at a meeting of the Joint Operating Committee may address the Joint Operating Committee with a limitation of five (5) minutes, in accordance with the policy established by the Joint Operating Committee.</p>

<p>SC 1850.1</p>	<p>Section 8. <u>Voting By The Joint Board</u></p> <p>All actions of the Joint Board shall be by a majority vote of the members of the Board, either in convention or by mail ballot, as selected by the Joint Board.</p> <p>Section 9. <u>Voting By The Joint Operating Committee</u></p> <p>All motions shall require for adoption a majority vote of those Joint Operating Committee members present and voting, except as provided by statute or Joint Operating Committee procedures.</p> <p>a. The following actions require the recorded affirmative votes of two-thirds of the full number of Joint Operating Committee members:</p> <ol style="list-style-type: none"> <li>1. Transfer of budgeted funds during the first three (3) months of the fiscal year.</li> <li>2. Transfer any unencumbered balance, or portion thereof, from one appropriation to another, or from one spending agency to another during the last nine (9) months of the fiscal year.</li> <li>3. Adopt or change textbooks without the recommendation of the Administrative Director.</li> <li>4. Dismiss, after a hearing, a tenured professional employee.</li> </ol> <p>b. The following actions require the recorded affirmative votes of a majority of the full number of Joint Operating Committee members:</p> <ol style="list-style-type: none"> <li>1. Fixing the length of the school term.</li> <li>2. Adopting textbooks recommended by the Administrative Director.</li> <li>3. Appointing the Administrative Director and Assistant Administrative Director.</li> <li>4. Appointing teachers and principals.</li> <li>5. Adopting planned instruction.</li> <li>6. Establishing additional schools or departments.</li> <li>7. Designating depositories for center funds.</li> </ol>

<p>Pol. 610</p>	<p>8. Expending the center's funds.</p> <p>9. Entering into contracts of any kind, including contracts for the purchase of fuel or any supplies where the amount involved exceeds \$100 (including items subject to \$10,000 bid requirements).</p>
<p>SC 1850.1</p>	<p>10. Fixing salaries or compensation of officers, teachers, or other appointees of the Joint Operating Committee.</p>
<p>SC 514, 1080</p>	<p>11. Dismissing, after hearing, a nontenured employee.</p>

<p>SC 708</p>	<p>13. Vacating and abandoning property to which the Joint Operating Committee has title.</p>

Determining the holidays, other than those provided by statute, which shall be observed by special exercises and those on which the schools shall be closed for the whole day.</p> <p>15. Removing a Joint Operating Committee member.</p> <p>16. Declaring that a vacancy exists on the Joint Operating Committee by reason of the failure or neglect of a school director to qualify.</p>

Sec. 706</p>	<p>Section 10. <u>Minutes</u></p> <p>The Joint Operating Committee shall cause to be made, and shall retain as a permanent record of the center, minutes of all open meetings of the Joint Operating Committee. Said minutes shall be comprehensible and complete and shall show:</p> <p>a. The date, place, and time of the meeting.</p> <p>b. The names of Joint Operating Committee members present.</p> <p>c. The presiding officer.</p> <p>d. The substance of all official actions.</p>

<p>65 Pa. C.S.A. Sec. 705</p>	<p>e. Actions taken.</p> <p>f. Recorded votes and a record by individual members of all roll call votes taken.</p> <p>g. The names of all citizens who appeared officially and the subject of their testimony.</p>
<p>SC 433</p>	<p>The Joint Operating Committee Secretary shall provide each Joint Operating Committee member with a copy of the minutes of the last meeting prior to the next regular meeting.</p> <p>The minutes of Joint Operating Committee meetings shall be approved at the next succeeding meeting and signed by the Secretary of the Joint Operating Committee.</p> <p>Notations and any tape or audiovisual recordings shall not be the official record of an open public Joint Operating Committee meeting and should be destroyed once they have served their purpose.</p>

Sec. 703, 709 Pol. 006</p>	<p>Section 11. <u>Adjournment</u></p> <p>The Joint Operating Committee may at any time recess or adjourn to an adjourned meeting at a specified date and place, upon the majority vote of those present. The adjourned meeting shall take up its business at the point in the agenda where the motion to adjourn was acted upon. Notice of the rescheduled meeting shall be given as provided in Joint Operating Committee policy.</p>
<p>65 Pa. C.S.A. Sec. 707, 708</p>	<p>Section 12. <u>Executive Session</u></p> <p>The Joint Operating Committee may hold an executive session, which is not an open meeting, before, during, at the conclusion of an open meeting, or at some other time. The presiding officer shall announce the reason for holding the executive session; the announcement can be made at the open meeting prior to or after the executive session.</p> <p>The Joint Operating Committee may discuss the following matters in executive session:</p> <p>a. Employment issues.</p> <p>b. Labor relations.</p> <p>c. The purchase or lease of real estate.</p>

Consultation with an attorney or other professional advisor regarding potential litigation or identifiable complaints which may lead to litigation.</p> <p>e. Matters which must be conducted in private to protect a lawful privilege or confidentiality.</p> <p>Official actions based on discussions held in executive session shall be taken at a public meeting.</p> <p>Section 13. <u>Work Sessions</u></p> <p>The Joint Operating Committee may meet as a Committee of the Whole in an open meeting to vote on or to discuss issues. Public notice of such meetings shall be made.</p> <p>A meeting of the Committee of the Whole, not regularly scheduled, may be called at any time by the Chairperson. The Chairperson shall call such a meeting when requested to do so by Joint Operating Committee members. Public notice of such meeting shall be made in accordance with this procedure.</p> <p>The Joint Operating Committee Secretary shall provide notice of a meeting of the Committee of the Whole as per the notice provisions of Joint Operating Committee procedures.</p> <p>Section 14. <u>Committee Meetings</u></p> <p>Committee meetings may be called at any time by the committee chairperson, with proper public notice, or when requested to do so.</p> <p>A majority of the total membership of a committee shall constitute a quorum.</p> <p>Unless held as an executive session, committee meetings shall be open to the public, other Joint Operating Committee members, the Administrative Director, and the Chief School Administrator.</p> <p>A majority of the committee or the chairperson may invite Joint Operating Committee employees, consultants or other persons who may have special knowledge of the area under investigation.</p> <p>Joint Operating Committee members who are not committee members but who attend committee meetings may not vote on committee matters.</p>
